- To ensure transparency, accountability, and timely resolution of issues


➤ **Key Features:**

- Serve as a centralized communication channel for timely dissemination of important information, student-centric initiatives, academic opportunities, and national-level programs that benefit our student community.


While the portal has already been introduced, it has been observed that there is a pressing need to generate awareness and popularize SIGMA more widely so that every student can make use of it effectively.
